- Pre-entries postmarked by September 4<sup>th</sup> to be in the draw & avoid \$10 late fee
- Draw will be posted September 14<sup>th</sup> at [www.utbra.com](http://www.utbra.com)
- Late entries taken at barn day of race until 5:00 pm with \$10 late fee ~ Cash Only – no exceptions
- 70% of entry fee and 100% of added money will be jackpotted
- Draw preferences\* are a courtesy, depend on number of entries & will be handled to the best of our ability
- Next 20 runners only allowed in the barn holding area. Please be courteous in the holding pen
- No warm-up allowed in the barn arena during rakes, warm-up arena is provided outside, west of barn
