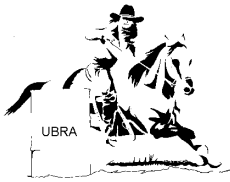

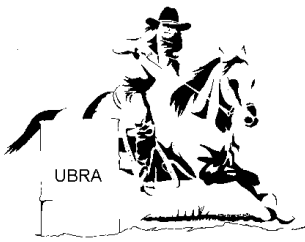

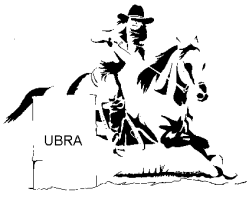

## 2010 UBRA Futurity & Luan's Leathers Open 5D

### April 24 & 25, 2010 Futurity\_Rules



1. The Futurity will be a 2D with 1/2 second split.
2. All runners will enter the arena thru the designated side gate and exit out the alley way. No exceptions. Any runner entering from anywhere other than the designated side gate will be disqualified.
3. Futurity nomination & fee schedule: \$100 nomination postmarked by Jan 25, 2010. Two payments thereafter: \$75 postmarked by Feb 25, 2010, \$75 postmarked by March 25, 2010. Total entry fee is \$250. No Exceptions on post mark and late fees.
4. The Futurity is open to all riders. A rider may ride more than one horse.
5. Western Wear is required, including long sleeve shirt, long pants, boots and hat in Futurity and all other races.
6. Futurity is open to foals of 2005 or after; copy of both sides of registration papers must accompany nomination payment. Unregistered horses must show proof of age with a vet's affidavit and must accompany nomination payment.
7. To be eligible for the Futurity horse must never have competed in a barrel race prior to December 1, 2009.
8. To be eligible for the Amateur 2D side-pot rider cannot have won more than \$2000 lifetime in barrel racing futurities and never before held a WPRA Card.
9. Horse/Rider futurity substitutions will be allowed for death, illness or unsoundness with a \$50 change fee. Deadline for substitutions is 4:00 pm April 23, 2010.
10. 75% of entry fee & 100% of added money will be jackpotted. All nomination fees and payments will be included in payout. Two go's and an average will be paid in the Futurity: 60% to 1D, 40% to 2D. (1<sup>st</sup> go 30%, 2<sup>nd</sup> go 30%, Average 40%). Average prizes will be awarded in the futurity.
11. Futurity horses will be numbered and markings checked against original registration papers at mandatory check-in on Friday, April 23 2010 from Noon to 5:00 pm. or Saturday April 25 from 8 - 9 a.m. Please bring **original registration papers** to Check-In.
12. Late nominations may be made by paying a \$25 late fee plus \$10 for each missed payment or payment not postmarked by the due date. The last day to enter the Futurity is Friday April 23, 2010 by 4 p.m. Any fees paid after April 12, 2010, including late fees, must be cash or certified funds. Late fees and substitution fees will be retained by the UBRA.
13. Horses running in Futurity **may carry over** time into the Open 5D & WPRA Side-pot. Future Champions (Sat.) then 5D will run approximately 30 minutes after the Futurity, not before 12 Noon.
14. **Absolutely no refunds of futurity nomination or entry fees – no exceptions.**
15. To reserve stalls please call Davis County at 801-451-4091. No tying at trailers over-night.
16. Ground will be raked every 5 runners with a tractor and big drags will be determined.

- ⓐ Open 5D will be ½ second splits and will start 30 mins after the futurity, not before 12 noon. WPRA side-pot and Pro Elite Stallion Incentive: Please see the WPRA's website for rules and information [www.wpra.com](http://www.wpra.com)
- ⓐ Future Champions: 9 and under as of April 1, 2010. This is for our future barrel racers not running in the open or youth that still need a little encouragement. Limited to one entry per rider. **Everyone gets a prize!!**
- ⓐ All runners will enter the arena thru the designated side gate and exit out the alley way. No exceptions. Any runner entering from anywhere other than the designated side gate will be disqualified.
- ⓐ Dress code required for Open and Futurity – long sleeve shirt, long pants, boots and hat.
- ⓐ 5D Pre-entries must be postmarked by 4/12/10. Late entries taken day of race until first big drag at 50 runners with a \$10 late fee. Late entries taken on Saturday for both days will run at the end on Saturday and Sunday.
- ⓐ Pre-entered day runners will be included in the draw. There will be separate draws done for the Open 5D Saturday and Sunday, late entries will run at the end Saturday and Sunday.
- ⓐ Saturday running order will be: Futurity, Future Champions, Open 5D. Sunday running order will be: Futurity (reverse), Dog Race, Open 5D.
