UBRA 2012 Rocky Mountain Power Futurity Rules April 28 & 29, 2012

1. The Futurity will be 2D with 1/2 second split.
2. All runners will enter the arena thru the alley way and exit out the alley way. No exceptions. Any runner entering from anywhere other than the alley way will be disqualified. One circle is allowed. If you are in the warm-up arena, please be cautious and courteous of horses running in and out of the alley way. The next 15 runners will be the only horses allowed in the warm-up arena.
3. Futurity nomination & fee schedule: \$100 nomination postmarked by February 1, 2012. Two payments thereafter: \$75 postmarked by March 1, 2012, \$75 postmarked by April 2, 2012. Total entry fee is \$250. No Exceptions on postmark and late fees.
4. The Futurity is open to all riders. A rider may ride more than one horse. Owners do not have to ride horses. Jockey to be named by day of show.
5. Dress Code: long sleeve shirt, long pants, boots and western hat or helmet is required in Futurity and all other races.
6. Futurity is open to foals of 2007 or after; copy of both sides of registration papers must accompany nomination payment. Unregistered horses must show proof of age with a vet's affidavit and must accompany nomination payment.
7. To be eligible for the Futurity horse must never have competed in a barrel race prior to December 1, 2011.
8. To be eligible for the Amateur 2D side-pot rider cannot have won more than \$2000 lifetime in barrel racing futurities and never before held a WPRA Card.
9. Horse/Rider futurity substitutions will be allowed for death, illness or unsoundness with a \$50 change fee. Deadline for substitutions is 4:00 pm **April 20, 2012**.
10. 75% of entry fee & 100% of added money will be jackpotted. All nomination fees and payments will be included in payout. Two go's and an average will be paid in the Futurity: 60% to 1D, 40% to 2D. (1st go 30%, 2nd go 30%, Average 40%). Average prizes will be awarded in the futurity. Must be present or have a designated person pick up your award.
11. Futurity horses will be numbered and markings checked against original registration papers at mandatory check-in on Friday, April 27, 2012 from Noon to 4:00 pm. or Saturday April 28, 2012 from 8 – 9 a.m. Please bring original registration papers to Check-In.
12. Late nominations may be made by paying a \$25 late fee plus \$10 for each missed payment or payment not postmarked by the due date. The last day to enter the Futurity is Friday April 27, 2012 by 2 p.m. Any fees paid after April 13, 2012, including late fees, must be cash or certified funds. Late fees and substitution fees will be retained by the UBRA.
13. Horses running in Futurity **may carry over** time into the Open 5D, and WPRA open side-pot. Future Champions (Sat.) will run right after the Futurity has ended. The 5D will run approximately 30 minutes after the Future Champions, not before 11:30 a.m.
14. Absolutely no refunds of futurity nomination or entry fees – no exceptions.
15. To reserve stalls please visit www.utbra.com under the Futurity page there will be a link to the stall reservation page. No tying at trailers over-night and no outside shavings are allowed. Dogs are not allowed inside the barn, but can be tied to trailers.
16. Ground will be raked every 5 runners with a tractor and big drags will be determined.
17. The futurity is WPRA co-sanctioned with WPRA PESI Incentive money bonus. Horse (if eligible) must be nominated with WPRA for WPRA points & PESI Incentive. Please see the WPRA's website for rules, futurity/PESI nomination information www.wpra.com. All PESI Incentives paid by WPRA.
