The above named applicant hereby represents and warrants that the foregoing information is true and correct as of the date hereof, and hereby makes application for the membership in the Utah Barrel Racing Association (UBRA), a Utah Non-Profit corporation, and in consideration for the granting of said membership, said applicant hereby agrees to abide by the articles of incorporation, by-laws, and all rules and regulation adopted and promulgated by said corporation, and agrees to indemnify and hold harmless said subsidiaries, affiliated companies and co-sponsors from any and all claims, suites and law or equity, liabilities or any other obligations arising out of, connected with, or predicated upon said sponsored, approved and or underwritten by said corporation other than such obligations arising out of the negligent acts or omission of said corporation.

In consideration of being permitted to enter for any purpose a restricted area (herein defined as the areas to which admission by general public and spectators is prohibited), or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in the event, each of the undersigned, for himself, his personal representatives, heirs, next of kin, acknowledges, agrees and represents that he has, or will immediately upon entering any of such restricted areas, and will continuously thereafter inspect such restricted area or areas and all portions thereof which he enters and with which he comes in contact, and he does further warrant that his entry upon such restricted area or areas and his participation, if any, in the event constitutes an acknowledgment that he has inspected such restricted area and that he finds and accepts the same as being safe and reasonably suited for the purposes of his use, and he further agrees and warrants that if, at any time, he is in or about restricted areas and he feels anything to be unsafe, he will immediately advise the officials of such and will leave the restricted area(s):

1. Hereby releases, waives, discharges and covenants not to sue the Utah Barrel Racing Association, or the promoters, other participants, operators, officials, any persons in a restricted area, sponsors, advertisers, owners, and lessees of premises used to conduct the event and each of them, their officers and employees, all for the purpose herein referred to as "UBRA", from all liability to the undersigned, his personal representatives, assignees, heirs, and next of kin for any and all damage, and any claim or demands therefore on account of injury to the persons or property or resulting in death of the undersigned, whether caused by the negligence of the UBRA or otherwise while the undersigned is in or upon the restricted area and/or, competing, officiating in, observing, or working for, or for any purpose participating in the event;
2. Hereby agrees to indemnify and save and hold harmless the UBRA and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the UBRA or otherwise;
3. Hereby assumes full responsibility for any risk of bodily injury, death or property damage due to the negligence of UBRA or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for or for any purpose participating in the event;
4. Each of the undersigned expressly acknowledges and agrees that the activities at the event and in the restricted areas are dangerous and involves the risk of serious injury, death, and/or property damage. Each of the undersigned further expressly agrees that the foregoing release, waiver and indemnify agreement is intended to be as broad and inclusive as is permitted by law of the Province or State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

The undersigned has read and voluntarily signs the release and waiver of liability and indemnity agreement, and further agrees that no oral representations, statements or inducement apart from the foregoing written agreement have been made.

This waiver, release and indemnification agreement specifically embraces each and every event sanctioned, authorized or promoted by said UBRA during the entire season and applies to each and every event, or activity herein above mentioned, and has the same effect as if executed after each and every activity or event in which the undersigned participates so that the parties herein intended to be released and indemnified shall be fully and effectively released and indemnified as to each and every event herein above described.
