



**UBRA \$5,000 Added**  
**Rocky Mountain Power 2D Futurity Rules**  
**April 22, 23 & 24, 2022**  
**Wasatch County Events Center, Heber City UT**



Futurity 2D (Full sec split), \$5000 Added & Average Awards  
\$300 entry fee, 1 payment due April 1, 2022 through SaddleBook  
\$250 Added 2D Amateur Side Pot 100% Payout (1/2 sec split) \$50 entry fee  
WPRA Co-sanctioned

Photocopy of front & back of registration papers or vet's affidavit must be uploaded with entry in SaddleBook

1. The Futurity is a 2D, full second split.
2. The futurity will start at 9:00 am Saturday and Sunday. 1<sup>st</sup> go: Pre-entries followed by late entries. 2<sup>nd</sup> go: Entire draw is reversed – late entries will run first in reverse order.
3. All runners will enter the arena thru the alley way and exit out the alley way. No exceptions. Any runner entering from anywhere other than the alley way will be disqualified. One circle is allowed. If you are in the warm-up arena, please be cautious and courteous of horses running in and out of the alley way. The next 15 runners will be the only horses allowed in the warm-up arena.
4. Futurity entry fee of \$300 (one payment) due April 1, 2022. Late fee after April 1st is \$50. **Absolutely no refunds of futurity entry fees or late fees – no exceptions.**
5. The Futurity is open to all riders. A rider may ride more than one horse. Owners do not have to ride horses.
6. Dress Code: long sleeve shirt, long pants, boots and western hat or helmet is required in Futurity and all other races Saturday and Sunday.
7. Futurity is open to foals of 2017 & 2018 (4 & 5 years old); copy of both sides of registration papers must be uploaded with entry in SaddleBook. Unregistered horses must show proof of age with a vet's affidavit and must accompany entry in SaddleBook.
8. To be eligible for the Futurity horse must never have competed in a barrel race prior to November 15, 2021.
9. To be eligible for the Amateur 2D side-pot rider cannot have won more than \$2,000 lifetime in barrel racing futurities prior to November 15, 2021, and never before held a WPRA Card.
10. Horse or Rider futurity substitution will be allowed for death, illness or unsoundness with a \$25 change fee and Vet / Dr. release. Cannot substitute both horse and rider. Notify Kristi Brangle 801-440-0827. Email release to [krbrangle@hotmail.com](mailto:krbrangle@hotmail.com) **Deadline for substitution is Monday, April 18, 2022.** \$25 change fee must be paid at time of substitution.

11. Futurity buy-outs will be allowed with payment of a \$25 fee and will be handled by The UBRA. **Buy-out deadline is Monday, April 18<sup>th</sup>. Absolutely no refunds of futurity nomination or entry fees – no exceptions.**
12. 70% of entry fee & 100% of added money will be jackpotted. All nomination fees and payments will be included in payout. Two go's and an average will be paid in the Futurity: 60% to 1D, 40% to 2D. (1st go 30%, 2nd go 30%, Average 40%).
13. Average prizes and money will be awarded in the futurity. A true average system using the combined horse & rider's times from each day will determine the futurity average champion and 2D futurity average champion. Must be present or have a designated person pick up your award.
14. Futurity horses will be numbered and markings checked against original registration papers at mandatory check-in on Friday, April 22<sup>nd</sup> from Noon to 4:00 pm in the warm-up arena, please bring **original registration papers** to Check-In.
15. Late nominations may be made by paying a \$50 late fee. The last day to enter the Futurity is Friday April 22, 2022 by 2 p.m. All fees must be paid through SaddleBook. Late fees and substitution fees will be retained by the UBRA.
16. Horses running in Futurity **may carry over** time to Youth, High Stakes, Open 5D and any eligible side-pots.
17. Stall Reservations are handled by Wasatch County and done online. To reserve stalls see [www.utbra.com](http://www.utbra.com) Heber Races page and follow the link to Wasatch County's stall reservation system. No tying at trailers over-night and no outside shavings are allowed.
18. Dogs are not allowed inside the barn but can be tied to trailers.
19. Ground will be raked every 5 runners with a tractor and big drags will be determined. Horses will not be worked on markers, barrels are not allowed in the arena during open ride or any other time April 22-24, 2022 except during time only.
20. The futurity is WPRA co-sanctioned. Horse (if eligible) must be nominated with WPRA for WPRA points. Please see the WPRA's website futurity page for rules [www.wpra.com](http://www.wpra.com)

## 2022 UBRA Open, Maturity, Youth, High Stakes & Side-pot Rules, Clarifications & Disclaimer

**NO DOGS** allowed in the indoor arena.

**Horse must be entered with registered name through SaddleBook.**

**Horse and rider must run in order drawn** or be disqualified. There is no charge for a horse change in the Youth and/or 5D for horses that are not already included in the draw.

**Friday:**

**Time Only** sold through SaddleBook.

**KK Jr World Qualifier Poles.** See KK run for Vegas to enter and for more information

**Friday Open 5D** (1/2 sec split) runs after KK Qualifier. 15 Yrs & Under 3D (full sec) side-pot. Member Incentive side-pot is for current 2022 UBRA/Barrel Buddies Members, 50+ and Stuck in the Middle (16-49 yrs old day of race) side-pots are 4D (1/2 sec split).

**Saturday & Sunday:**

**Futurity** – see futurity rules.

**2D Maturity** is 1/2 sec. split, open to all 2<sup>nd</sup> and 3<sup>rd</sup> year horses 8 years and younger. Maturity will run after the futurity Sat and Sun. Separate draws ea. Day. Can c/o to Youth, High Stakes, 5D & other side-pots.

**KK Jr World Qualifier Barrels.** See KK run for Vegas to enter and for more information.

**Youth 3D** full second split for any rider 15 and under day of the race. Youth can carry over to High Stakes, Open 5D & Target Race and will run after the Maturity Sat. and Sun. Youth 3D Average awards will be based on the fastest time from each day. Must pick up award or have someone pick it up for you.

**High Stakes 4D** 1/2 second split, will run after the Youth Saturday and Sunday. 100% Payback. Pre-entries can c/o to Open, Target and all eligible side-pots. Late entries will run in the open and carry time to the High Stakes Sat. and Sun.

**Open 5D** 1/2 second split and will run after High Stakes. 70% of entry fee & 100% of added money will be jackpotted. 5D Average awards will be based on the fastest time from each day.

**Side-pots** - Member incentive, 50+, Stuck in the Middle (16-49) are 4D (1/2 sec split).

**\$1000 Cash Target Race** side-pot (Open & Youth Combined), horse and rider with the two closest times Sat & Sun will win \$1000 cash! Target prizes will also be awarded.

**Dress code** Sat. & Sun. western attire, long sleeve shirt (collar not req.), long pants, western boots, western hat or helmet. No dress code Friday.

**WPRA:** Open, Futurity & Derby are WPRA Co-approved.

**Entries** must be submitted through Saddlebook, \$10 late fee after April 14<sup>th</sup>. Payment accepted by CC with fees. Late entries run at the end Friday, Saturday and Sunday.

Pre-entered day runners will be included in the draw. There will be separate draws done for Saturday and Sunday. The first late draw will be posted on SaddleBook by the big drag before the last 50 pre-entries.

**Running Order:** Friday 5:00 pm: KK Poles Qualifier, Open 5D. Saturday 9:00 am Futurity, Maturity, KK Barrels Qualifier, Youth, High Stakes, Open 5D. Sunday: 9:00 am Futurity lates run first in reverse order, Futurity pre-entries in reverse order. Futurity Award Presentation. Maturity, Youth 3D, High Stakes, Youth Average Awards, Open 5D (new draw), 5D Average Awards Presentation. Must be present or have a designated person pick up your award at the race.

**All runners will enter the arena thru the alley way** and exit out the alley way. No exceptions. One circle is allowed. Any runner entering from anywhere other than the alley way will be disqualified. If you are in the warm-

up arena, please be cautious and courteous of horses running in and out of the alley way. The next 15 runners will be the only horses allowed in the warm-up arena.

**Horses will not be worked on markers** and barrels are not allowed in the arena during open ride or any other time April 22, 23 & 24, 2022 except during UBRA time only.

**Dr/Vet Outs** 70% of entry fee will be refunded with Dr/Vet release. Must notify the office before your draw spot runs. Refunds will be issued within 30 days after the event. Futurity entry fees and late fees are non-refundable.

**Stall** Reservations are handled by Wasatch County: visit [www.utbra.com](http://www.utbra.com) Heber page, follow the link to Wasatch County's stall reservation system. Stalls will be reserved upon full payment. If you are going to be late make sure you have made arrangements with the county ahead of time. No outside shavings allowed and please do not tie horses to trailers overnight.

**By submitting your entry, you agree to the following DISCLAIMER**

By signing and submitting your entry to any UBRA Event you agree that you are aware of and will abide by the Rules and Regulations of the Utah Barrel Racing Association. In addition and notwithstanding the foregoing, I hereby waive any and all claims which may arise between myself and the UBRA or between myself and third parties (i.e. Davis County, Salt Lake County, Weber County, Tooele County, Utah County, Herriman City, Wasatch County, West Jordan City, the Board of Directors and the agents, Wilderness Pro Rodeo, WPRA, Julie Herman, members, servants and employees) as a direct or indirect result of my participation in any UBRA event. Should anyone or any legal entity bring such a claim, I agree to indemnify and pay the reasonable costs and attorney's fees associated with defending the UBRA. My waiver does not include any claim I may have against the UBRA for monies won as a result of my competitive performance at a UBRA event. Applicant further agrees that the foregoing release, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by law and that if any portion thereof is held invalid, it is agreed that the balance shall continue in full legal force and effect. This Agreement embodies the entire agreement between UBRA and the Applicant. No verbal agreements or conversations with any agent of the UBRA prior to execution of this Agreement shall affect or modify any of the terms or obligations contained in any documents comprising this Agreement. This Agreement shall be governed by and construed in accordance with the laws of the State of Utah. The forum for resolution of any disputes arising under this Agreement shall be the Third District Court of the State of Utah. In the event Applicant institutes litigation to enforce his or her rights under this Agreement, the prevailing party in such litigation shall be entitled to an award of its reasonable attorney's fees and costs. EQUINE ACTIVITIES LAW By signing and submitting this application, I agree that I have been informed of the Utah Equine Activities Law (U.C.A. 78B-4-201 et seq.) and that there are certain risks inherent to my participation in an equine or livestock activity. I acknowledged that those inherent risks include dangers or conditions which are an integral part of equine or livestock activities, and may include the following: (a) the propensity of the animal to behave in ways that may result in injury, harm, or death to persons on or around them; (b) the unpredictability of the animal's reaction to outside stimulation such as sounds, sudden movement, and unfamiliar objects, persons, or other animals; (c) collisions with other animals or objects; or (d) the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within his or her ability.
