No Horses in RV Parking Please tack up at your stall.

Horses must be entered with registered name through SaddleBook.

Horse and rider must run in order drawn or be disqualified.

Horse Change There is no charge for a horse change for horses that are not already included in the draw. Must notify the office before you run.

Dress code: No Dress Code Friday, Saturday is Western Attire, No Dress Code Sunday.

Team Race:

Each team will consist of 10 barrel racers. If you don't know 10 people coming to the race, that's ok, we will have people that want to be on a team that we can add to your team. We are going to run the race in a 4D format to give everyone a chance to win.

Rules:

Teams consist of 10 runners. No rules on who you invite on your team.

An individual can only run once and can only be part of one team. If someone would like to run multiple horses on Friday, you can enter in the 4D that will run after the Team Race.

Each team must elect a Team Captain. The Team Captain will be responsible for contacting Angi for any changes on the team angihawthorne@gmail.com. The Team Captain is responsible for coordinating with the UBRA and their team members and making sure their team consists of 10 racers.

The teams will run together.

A downed barrel will add 5 seconds to the individual's time which adds to the cumulative team's time.
